The Organization also advocates for public policies that increase the efficacy of criminal and civil laws pertaining to sexual violence and exploitation.

4b (Code:) (Expenses \$ 268,724. including grants of \$) (Revenue \$) Policy and Advocacy: The Organization advocates for legislative and policy reforms that will increase legal and social accountability for perpetrators of harm, especially sex traffickers, pimps, people who buy sex, and those who commit sexual assault. The Organization also promotes broad community support for services and resources for survivors. The Organization advises law enforcement, policy makers, and other stakeholders on best practices relating to sex trafficking, prostitution, and rape.
